Subs

Subs are £195 or £146.25 (OAPs, unemployed and students) for the year. However, if you pay by the fourth rehearsal of the season (i.e. no later than 4 October 2017) or by standing order you will benefit from a discounted rate – see details below. We would encourage you to pay within the early discount period!

Ideally we would like you to pay electronically (bank transfer or standing order).

Or you can pay by **cheque**, made payable to Brent Symphony Orchestra

The rates are as follows – the biggest discount is for paying early or by standing order!

Single payment at the beginning of the year (bank transfer or cheque).

Full rate: £195 (early discount £175) Concession: £146.25 (early discount £131.25)

Monthly standing order payable over **12 months** (Sept-Aug). The first payment must be made in **September**.

Full rate: £15 per month (total £180) Concession: £11.25 per month (total £135)

You can also set up a standing order of £15/£11.25 per month even if you are only playing for one or two terms. Please email the Treasurer, Jo White, at jo.white@brentso.org.uk to ask for details of when to start and stop!

Termly by bank transfer. There is no discount for this option.

Full rate: £65 per term Concession: £48.75 per term

* As a registered charity, we can claim Gift Aid on membership subs minus £3 per term. For your records, the amount of donation is therefore the full amount paid minus £3 per term, i.e. if you pay £175 for the whole year, your donation to BSO will be £166.
